- 1. PERC plant contract-Orrington's town manager Chris Backman came to talk to our Selectboard about the PERC plant and what he knew so far with his interactions with them. Has met them. Will have a meet and greet with the Grace LLC owners at Jeff's catering on Dec 14<sup>th</sup>. Chris said they are interested in repurposing the plant to a green energy gasification process which would heat the plant itself and create a gas they might sell later. First priority is to get the roof fixed, try to restart the plant, getting DEP/EPA licenses in place and also this contract is the balance of the 7 months to switch from PERC to Grace LLC for the landfill/contract agreement.**
- 2. Fish Pier/Harbor budgets-Evelyn went over budgets for both. Talked about mooring fee increases potentially to bridge the costs of inflation increases. Motion by Donna and 2<sup>nd</sup> John to approve them. 5-0**
- 3. Project updates-TM gave updates on truck, school building doing some room changing and painting, rugs replacements, need Bob Cat tires, TS signs.**
