Minutes from June 5, 2023-Motion by John 2nd by Donna to approve. 5-0

Weekly Warrants-Motion by John, 2nd by Donna to approve. 5-0

- 1. Harbor Committee recommendations-Evelyn read through minutes from HC meeting with recommendations to the Selectboard for transport permit fee change. Proposed 1000 a month for Nov-June 1500 for July -October. Board discussed, no vote to support. Board ok with \$11K match for Shore and Harbor grant for Odd Fellows planning/design work.
- 2. Ballfield park update-TM gave progress report, some prices, most of big playground equipment is done, but surface area needs to be completed, grassing in, but weather is impossible and too wet to work at site this week delaying work again.
- 3. Baler prices- Transfer Station-TM had some quoted for new and refurbished baler prices. Board discussed either new or old one. Motion by John 2<sup>nd</sup> by Donna to get refurbished model baler for \$13,680 from Atlantic Recycling and \$1500 for electrical installation to come from the TS Reserve account. 5-0
- 4. Pickleball court-ICC request-TM said request came from ICC about taking the old playground space and turning it into a pickleball park. They are willing to fund it. TM said hard to lose more parking as we are trying to maintain what we have. Travis said at their meeting they mentioned it. Board said why don't pave

- down back and use that for court needs. Much cheaper for them than building new or use courts up to the school as they aren't used much.
- 5. PERC plant update-TM gave overview of current situation, and auction dates for viewing and bidding. July 12 is the date.

Old Business- had Chris Mayo down from SHIP grant program to talk about plans for IOOF, and the public landing.

New Business-TM passed around MOU about the rope at the dump and agreement and work Net your problem wants to charge us for maintain and loading the rope coming in. Board discussed, TM said they want same price as tipping for PERC, also we do labor they don't pay for. Not a good deal, plus with issues with PERC let's sit on it and see what transpires going on first. TM asked about Kyra's car at Dump. Board said no. TM said she agreed, we can't guarantee any issues with vandalism.
