Item 1: Attwood permit for a new dock, foot of Seabreeze Avenue

Permit is to fabricate and install a 20' x 100' float in Stonington Harbor.

Bill Damon was present representing the owners. The Board studied Google

Maps of the area as well as the permit. It was the consensus of the Board that
100' was too long and would interfere with existing moorings. After
discussion it was moved Boyce second Turner that Board was not willing to
permit a 20' x 100' dock but would be willing to permit either a 20' x 60'
or a 30' x 60' dock. Vote 5-0 It was suggested that the owners modify their
permit application to meet either of these guidelines & send to required parties.

- Item 3: Fish Pier Financials Moved Boyce second Larrabee to accept Vote 5-0 Harbor Financials Moved Boyce second Dworsky to accept Vote 5-0
- Item 4: Ordinance or policy changes Kathleen Billings asked if the Board wished to recommend any changes. Board noted that they thought a couple of areas needed to be altered. Possible recommendations will be worked on by Billings and Duncan and brought to the Boards next meeting.
- Item 5: Stipend for Mike Vandegenacate for helping assistant harbormaster on different repairs on the fish pier. Moved Larrabee second Boyce to give him \$ 500.00 Vote 5-0
- Item 6: Bergen mooring tabled again.
- Item 7: Kathleen Billings voiced her concerns about agriculture in Stonington waters in the future. She asked the Board if they would work on a guide which would include location and size limitations of possible agriculture sites.
- Item 8: Lobster rule updates. Board thought the rally was a success with good participation and good speakers. To date almost \$ 10,000 has been donated to the legal fund. Duncan told Board that the Selectmen are going to have a special Town meeting which will include a warrant article for \$ 10,000 to be taken from surplus and divided between the Union and MLA for the appeal. Kathleen Billings told the Board that Senators Collins has asked to have a round table meeting to discuss solutions.

- Item 5: Aquaculture 41 acre lease in Deer Isle. Board concerned about size of lease and will carefully study any lease application in Stonington waters.
- Item 6: Board signed letter to aquarium in California regarding their false announcement of sustainability of Maine fishing grounds. It also talked about the request from the Selectmen about whether funds should be given to the court appeal. Dworsky informed the Board that the Union is not involved at this time but MLA is appealing. The Board feels that the Town should donate \$ 5,000 to the MLA legal fund. Duncan will tell the Select board.
- Item 7: Duncan reported that harbor dredging may be getting closer. Kathleen Billings confirmed that a representative is coming to Stonington probably in about two weeks to check out the channel etc.
- Item 8: Duncan suggested the Board should start to consider budget, especially the Fish Pier. Board needs to figure what expected income and expenses are going to be in 2023.

They also stated that an offshore testing of the ropeless equipment should be made to see if it will work. They also reported that several fishermen have already put their vessels on the market. It is their hope that the court case is not over yet.
- Item 5: The Board was not sure where exactly Bergen's mooring was located, therefore the possible use of this spot by the individual who bought the rock could not be made. Harbormaster will find out where this mooring is and report back next month.

ITEM 1: Minutes June 2022 Approved and signed

- ITEM 2: Financials Fish Pier Moved Stevens second Boyce to accept Vote 4-0 Financials Harbor Moved Stevens second Boyce to accept Vote 4-0
- ITEM 3: Nick Haskell fish pier boat use permit. Board willing to accept new permit, have office get application and fee
- ITEM 4: Mooring application McConnell

 Duncan reported that she was unable to find the application at the office.

 Dana Webb will try and get information and relay onto Board. Location request seems OK, no waiting list in that area. Telephone vote may be possible
- ITEM 5: Hoist accident. Accident recorded on camera's. Jeremy is making a new boom. Invoices for damage will be the responsibility of the owner of the truck which caused the damage.
- ITEM 6: Duncan reported that Due North has given the Town a quote of \$2,000 to ping the moorings of Stonington waters and create maps with latitude and longitude noted on them. Board considered that this was an extremely fair price, that Due North should do the project, and that it would be a great help in identifying moorings for billing purposes.
- ITEM 7: Odd Fellows Hall. Duncan reported that the grants are in place to purchase the Odd Fellows hall by the Town. Town Manager will look into the possibility of SHIP grants for the water portion of the property. What would the Board like to see constructed on that portion of the property? After discussion Board's suggestions were:
 - 1: Dredge area
 - 2: Replace existing dock and make it its original configuration which was about 10' longer
 - 3: Ramp coming off property
 - 4: Dingy floats that would not be connected to existing fish pier dingy floats.
 - 5: Who could use dingy floats. Undecided at this time, unsure of grant requirements.
 - 6: Drawing may be in harbormaster office if found attach to minutes

ITEM 8: Boyce suggested that additional new mooring space could be available down off Indian Point Road. Boyce showed Board chart of area. Board thought there might be room, Dana Webb will print chart area for Board to study. If decided upon, waiting list would get first refusal. Chart area attached

ITEM 9: Harbormaster report

The number 4 hoist drum is wire and was leaking. Dana Webb reported that The drum was all corroded and that this was the original unit. A new one using rope will be installed. All the drums will now be the same. After discussion Moved Boyce second Larrabee that a spare unit with brake be purchased. Price is about \$1,800 Vote 4-0

Dana Webb has had to replace two fuel nozzles on pump. He will purchase two spares from Amazon for \$84.00 each. Boats have been using a lot of fuel and the price is now \$3.93. But he cannot say what pricing will be in future as it keeping going up and down.

Dana Webb reported that there is a pontoon float attached to Flea Island, he has not been able to find out who owns the float and no application has come to Board. No one on Board knows who it belongs to. Can the Town office help?

ITEM 10: Duncan asked Board about fees for 2023. Does the Board want to go up on any of its fees. Board said it went up last year, and that fishing season is an unknown at the present time. It's initial thought is to leave pricing the same but they will revisit issue again later in the season.

Item 1: Minutes April 2022 Tabled lack of quorum from April meeting

Item 2: Jeff Warner would like to move his mooring from Webb's Cove to East of Isle au Haut dock near the red can in Stonington harbor. He does not have access to old mooring which was a Bill Bakers former property. He has a 32' sailboat and a 5000 pound rock. Board checked the waiting list there was no one ahead of Warner either looking for a mooring there or had a suitable size vessel for that spot. Moved Turner second Larrabee to allow Warner to have this spot. Boat will be considered pleasure at this time.

Item 3: Financials

Moved Larrabee second Turner to accept Harbor financials Moved Stevens second Turner to accept Fish Pier financials Duncan noted that the fish pier is down two Transporter fees but one trucker is working on filling out the permit. Diesel sales are down almost 40,000 gallons. Many boats have not launched yet.

Item 4: Moorings

Board will wait a couple of weeks before going out to record moored boats. It is going to be a hard job as many boats are using other owners moorings. Board was given a list of people not billed yet who have been billed in past, they will go over and fill in any information they know and give them to Dana. Turner reported that he was approached by the Webb's Cove marina operator about putting in more moorings in Webb's Cove, no decision needs to find out who is presently using moorings there and need to check with clam committee.

Item 5: Turner suggested that they take checks only at pier, not cash as that should help identify who is paying for a mooring by cash when it really belongs to someone else.

Item 6: Harbormaster report

Boat is ready, hoists have been greased, still waiting for Leighton to show up, new nozzle of fuel pump, and fixed line on fuel pump. Added three more pier boat users to list.

Item 3: Harbormaster report

Webb and Billings are working on permits about 90% of the user fees are in 100% parking fees in

Larrabee commented that he does not approve of the application line requesting information on bait.

Billings has reviewed the oil spill policy and has purchased boxes for spill supplies which will be placed near the fuel pumps

Two cameras have been replaced

Billings has approached the urchin divers and they have moved their trailers.

They are also not unloading product at Hagan dock but leaving product in boats and taking product away when they haul out.

Webb reported that the scissor jack works well but with the cold weather it has frozen ignition switch, dead battery, etc. It needs to be inside. As pier does not have a suitable trailer or a suitable shed this is a problem. Covering, trickle charging was suggested. No firm decision found at present

Item 4: Old Business

Billings wanted to confirm that the Board did not want to change mooring fees. Answer was yes.

Billings would like to change the lottery for Hagan dock skiff space to first of April. Board agreed.

Billings reported that he had not sent a Transporter form to Brewer. Board agreed that whether or not they were a transporter was a grey area and not to send anything at this time.

Item 5: New Business

Board members agreed to help the Harbormasters with the mooring list both now and when vessels are in water so an accurate list for invoicing and documentation fees can be established. It was suggested that the Harbormaster

- Item 6: Go over Harbor policies and make a few changes before submitting to Selectmen at their next meeting
