The Town of Stonington/Stonington Water Company is requesting Bids for the construction of the following Project:

School Street Water Main Replacement
OA2152

Bids for the construction of the Project will be received at the Stonington Town Office, 32 Main Street, Stonington, Maine 04681, until March 20, 2026 at 1:00 P.M. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Work under this project includes, but is not limited to, approximately 1,770 LF of 6 and 8"Ø DI water mains, 480 LF of water services, 4 hydrants and 11 - 8"Ø valves, bituminous trench and roadway pavement, indeterminate ledge removal, and all site work, test pits, earthwork, erosion control, traffic control, restoration of disturbed areas, loam and seeding, and all incidentals as required for a complete project.

Bids are requested for the following Contract: School Street Water Main Replacement

The project has an expected duration of 150 days.

Printed copies of the Bidding Documents may be obtained from the Issuing Office by paying \$150 for each set plus \$40 to mail.

Pre-bid Conference

A pre-bid conference for the Project will be held on February 20, 2026 at 11:00 A.M. at the Stonington Town Office, 32 Main Street, P.O. Box 9, Stonington, Maine 04681. Attendance at the pre-bid conference is encouraged but not required.

Instructions to Bidders.

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents.

This project will require compliance with the Federal Build America, Buy America Act (BABA) per the Supplementary Conditions (BABA-1).

Bid Bond

“A bid must be accompanied by Bid security made payable to Owner in an amount of 5% of Bidder’s maximum bid price and in the form of a certified check or Bid bond issued by surety meeting the requirements of the General Conditions.”

Agency Not a Party

“This contract is expected to be funded in whole or in part by the State of Maine Drinking Water State Revolving Loan Fund (DWSRF) funding. Neither the State of Maine nor any of its departments, agencies, or employees is or will be a party to this contract.”

SRF Disadvantaged Business Enterprises Program

“The contractor must comply with the Disadvantaged Business Enterprises (DBE) requirements contained in the DWSRF Supplementary Conditions.”

Federal Requirements

“The contractor must comply with all Federal Requirements per the DWSRF Supplementary Conditions.”

Davis-Bacon and Related Acts

“The contractor must comply with the Davis-Bacon Related Act per the DWSRF Supplementary Conditions. All laborers and mechanics employed by the contractor and subcontractors on this project shall not be paid less than the prevailing wage rates contained in the wage determination published in the bidding documents.”

Non Discrimination in Employment and Labor Standards

Bidders on this work will be required to comply with the President’s Executive Order No. 11246 and amendments or supplements to that Order. The requirements for bidders and contractors under this Order are explained in the Notice to Contractors.
