- 1. Old School building renovation- MCA grant-connectivity hub-**  
Linda came in with Morgan Witham on the grant submitted, working partners, digital literacy, telehealth, moving adult Ed, and the potential renovation with elevator for ADA. Linda had a handout about the concept, who partners are and timeline of project if awarded the grant. Other partners may stay there anyway like Adult Ed by switching rooms.
- 2. DI Causeway-MDOT online comments/meetings-TM and Linda gave out dates for the DOT process, the Deer Isle meeting with the online presentation DOT has done and what it means on April 23<sup>rd</sup>, last time for substantial commenting before comments end on 4/30. Important to be there and tell everyone to come, both towns encouraging participation with media as well.**
